TYPE OF START: DOCK START
PRIZE MONEY: \$4,000 MINIMUM, PLUS TROPHYS OR PLAQUES TO TOP 3 OVERALL FINISHERS, BASED ON 15 ENTRIES
ENTRY FEE: \$200 TO AMERICAN DRIVERS, \$50 DISCOUNT TO PRO TUNNEL TOUR MEMBERS. NO FEE TO FOREIGN DRIVERS
TELEVISION: LOCAL CABLE COVERAGE IS ANTICIPATED,
OFFICIALS: CHIEF REFEREE-DON ALLEN, SR., BALANCE TO BE ANNOUNCED
ADVANCE ENTRIES: ONLY REQUIRED FOR NON-USA DRIVERS. THIS IS TO ALLOW RACE ORGANIZER TO CONFIRM ALL PERTINENT DETAILS WITH DRIVER(S) PRIOR TO SHIPPING BOATS, ETC. MUST BE RECEIVED BY JUNE 15TH, 2004 AT ADDRESS SHOWN BELOW. FAX OR MAILED ENTRIES ARE ACCEPTABLE, BUT MUST BE TYPED IN THE ENGLISH LANGUAGE.

TRANSPORTATION FACILITIES: DETROIT METRO AIRPORT IS 20 MINUTES FROM RACE SITE. BOAT SHIPPED TO METRO BY A FOREIGN DRIVER CAN BE PICKED UP BY THE LOCAL RACE COMMITTEE AT NO CHARGE TO THE FOREIGN ENTRY (PROVIDING IT IS SHIPPED WITH A USEABLE TRAILER). A TOW VEHICLE CAN BE PROVIDED AT A NOMINAL CHARGE.

FOOD CONCESSIONS: SEVERAL IN THE SPECTATOR AREA ADJACENT TO THE PIT AREA.

INSURANCE: ALL FOREIGN DRIVERS PURCHASE INSURANCE COVERAGE, WHICH IS INCLUDED WHEN THE DRIVER JOINS APBA. THE MEDICAL COVERAGE IS UP TO \$20,000 AND THE LIABILITY COVERAGE UP TO \$5,000,000. CAN JOIN APBA AT THE RACE SITE FOR \$175. NO OTHER INSURANCE COVERAGES ARE ACCEPTABLE.

MINIMUM AGE: 16 YEARS OLD

PRACTICE TIME & INTERVAL BETWEEN HEATS: 1/2 HOUR ALLOWED EACH DAY. MINIMUM OF 2 HOURS BETWEEN HEATS UNLESS FORCE MAJEURE DICTATES OTHERWISE.

SCRUTINEERING (PRE-RACE INSP.) IN PITS BEWEEN 8 & 10AM SAT.

PUBLICITY: ALL PUBLICITY OTHER THAN THAT PROVIDED BY RACE COMMITTEE MUST BE APPROVED BY RACE COMMITTEE.

TIME LIMITS: ALL COMPETITORS HAVE 2 MINUTES MAXIMUM TO COMPLETE THE LAP THEY ARE ON AFTER THE 1ST PLACE FINISHER TAKES THE CHECKERED FLAG

PROTEST FEE: \$100 PLUS SHIPPING COSTS, IF NECESSITATED
